Pursuant to Article 11 of the Law, the data subject has the right to apply to MYD Endüstriyel Kimyevi Mad. San. Ve Tic. Ltd. Şti. through the methods determined by the Personal Data Protection Board and:

- Learn whether their personal data is processed or not,
- Request information if their personal data has been processed,
- If their personal data is processed, learn the purpose of processing personal data and whether it is used in accordance with its purpose,
- If their personal data is being transferred to third parties in the country or abroad, know those third parties to whom personal data is transferred,
- Request correction of personal data if it is incomplete or incorrectly processed, and request
  notification of the transaction made within this scope to the third parties to whom personal data
  has been transferred,
- Request deletion or destruction of personal data in case the reasons for processing disappear
  even though it has been processed in accordance with the Law and other relevant laws, and
  request notification of the transaction made within this scope to the third parties to whom
  personal data has been transferred,
- Object to the occurrence of a result against the person himself/herself by analyzing the processed data exclusively through automated systems,
- Demand compensation for the damage incurred due to unlawful processing of personal data.
