

The website with the domain name [www.mydtorn.com.tr](http://www.mydtorn.com.tr) ("Website") is responsible for determining the purposes and means of processing personal data, and for establishing and managing the data recording system managed by "MYD Endüstriyel Kimyevi Mad. San. Ve Tic. Ltd. Şti." (hereinafter referred to as "MYD Endüstriyel ") located at Kurtuluşosb Mahallesi Zeki Müren Cadde No:4 Gürsu/Bursa as the data controller

In accordance with the Personal Data Protection Law No. 6698 ("Law"), we would like to inform you about the collection, storage, and transfer of your personal data obtained in connection with your use of the Website, as well as the processing<sup>1</sup> of such data within the scope of Article 3 of the Law titled "Definitions", and the procedures and principles related to such processing.

### 1. Purpose of Processing Personal Data:

According to Article 3 of the Law titled "Definitions", personal data refers to "any information related to an identified or identifiable natural person." This data may include information such as your name, address, email address, or phone number, etc. In addition, information/data collected using cookies, which do not directly allow your identification (e.g., how you use the Website, which parts of the site you visit), may be considered personal data if they are collected, stored, and evaluated on the basis of an identity assigned to the user/visitor in an individualized manner.

We process the personal data of internet users and visitors using the Website through cookies in order to facilitate the use of the Website and to customize the Website according to the interests and needs of users and visitors. We also process anonymous and aggregated statistical data that helps us to understand how users and visitors use the Website as well as to improve the structure and content of the Website. This data is not the information that allows us to identify you.

### 2. To Whom and for What Purposes Personal Data May Be Transferred:

Your collected personal data may be shared with authorized legal entities as per Articles 8 and 9 of the Law in order to fulfill our legal obligations as MYD Endüstriyel, to the extent necessary upon request by these authorized entities.

### 3. Method and Legal Basis of Collecting Personal Data:

Personal data related to current and potential internet users and visitors are collected by MYD Endüstriyel via placing cookies on the Website, based on the legal basis of MYD Endüstriyel's legitimate interest to conduct its activities and to offer products relevant to its field of activity, provided that it does not harm the fundamental rights and freedoms of data subjects.

### 4. Network Server Data Log:

When you access the Website, your web browser is set to automatically transfer the following data to our internet server, after which the following information/data will be recorded in the data logs:

- Date of access,
- Time of access,

<sup>1</sup> According to Article 3.1(e) titled "Definitions" of the Law, "Processing of Personal Data" refers to any operation performed on personal data including obtaining, recording, storing, preserving, altering, rearranging, disclosing, transferring, taking over, making available, classifying, or preventing the use of such data, whether fully or partially by automated means or by non-automated means provided that it is a part of any data recording system.

- URL of the application site,
- Retrieved files,
- Amount of data transmitted,
- Browser type and version,
- Operating system,
- IP address,
- Domain name of your internet service provider.

### 5. Cookies

Cookies are small text files placed on your hard drive by the web page server. Through this method, we automatically obtain certain data such as your IP address, browser type, operating system on your computer, and internet connection.

This Website uses Google Analytics, a web analytics service provided by Google Inc. (“Google”). Google Analytics uses cookies to help the website analyze how users use the site. The information generated by the cookie about your use of the Website (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your use of the Website, compiling reports on Website activity, and providing other services related to Website activity and internet usage.

The mandatory, functional, and analytical cookies used by our Website:

Are required for the proper use of the website interface and features.

Enable you to speed up activities during future visits.

Help us gather statistical data and develop content based on this data by providing us understand how visitors use the website.

- Do not collect, store, or process data that would allow us to identify you under any circumstances, and do not qualify as personal data.

	COOKIE TYPE	PURPOSE OF COOKIE USE
1.	<b>REQUIRED COOKIES</b>	These types of cookies are essential for the proper functioning of the Website and to enable you to use all the features it offers. An example for this may be remembering the previous actions when returning to a page within the same session. These cookies do not identify you. If you do not accept these cookies, you may not be able to benefit from all the features of the Website.
2.	<b>PERFORMANCE COOKIES</b>	These types of cookies collect information about how the Website is used, which helps us improve the Website. For example, they collect data/information about the pages you visit most, the time spent on the Website, and error messages you encounter. The data/information collected by these cookies is recorded anonymously. No information that could identify you is stored.

<b>3. FUNCTIONAL COOKIES</b>	These types of cookies allow us to provide you with a more personalized experience. For example, they enable us to remember data such as your username and language preferences, so you don't have to re-enter this information during subsequent visits. The information stored by these cookies is anonymous. If you do not accept these cookies, the performance and functionality of the Website may be affected, and access to some content on the Website may be restricted.
<b>4. TARGETING/ADVERTISING COOKIES</b>	These types of cookies are used to offer content/products that are closer to you and your interests. For example, <b>we do not use</b> targeting or advertising cookies to personalize the advertisements and content presented to you on the Website, to limit the frequency of seeing the same ad on the Website, and to measure the effectiveness of our advertising campaigns.

### 6. Managing Cookie Settings

We recommend that you accept cookies to use the Website as efficiently as possible. You can still view the Website without cookies. Internet browsers are set up to accept cookies by default. You can stop the use of cookies at any time through your browser settings. Please use your browser's help function to learn how to change your cookie management settings. Please note that some functions of our website may not work properly if you stop the use of cookies or change your cookie settings.

### 7. Rights of the Data Subject

Pursuant to Article 11 of the Law on the Protection of Personal Data, titled "Rights of the Data Subject," as a data subject, you have the right to request from **MYD Endüstriyel**, in writing or through other methods<sup>2</sup> determined by the Personal Data Protection Board, whether your personal data has been processed, request information if your personal data has been processed, learn the purpose of processing your personal data and whether they are used in accordance with their purpose, know the third parties to whom your personal data is transferred domestically or abroad, request the correction of your personal data if it is incomplete or inaccurately processed and request that the process carried out in this context be notified to the third parties to whom your personal data has been transferred, request the deletion or destruction of your personal data in the event that the reasons requiring the processing of your personal data disappear, even if it has been processed in accordance with the law and other relevant laws, and request that the process carried out in this context be notified to the third parties to whom your personal data has been transferred, object to the occurrence of a result against you by analyzing the processed data exclusively through automated systems, and demand the compensation of the damage if you suffer damage due to the unlawful processing of your personal data.

<sup>2</sup> According to the "Communiqué on the Procedures and Principles of Application to the Data Controller" dated 10.03.2018 and numbered 30356, data subjects can submit their requests within the scope of the rights specified in Article 11 of the Law to MYD Endüstriyel in writing or via a registered electronic mail (KEP) address, secure electronic signature, mobile signature, or by using the email address previously provided to MYD Endüstriyel and registered in the MYD Endüstriyel system, or through software or applications developed for the purpose of the application.

The requests in your application will be concluded free of charge by **MYD Endüstriyel** as soon as possible and within thirty days at the latest, depending on the nature of the request. However, if the process incurs an additional cost for **MYD Endüstriyel**, a fee may be charged according to the tariff determined by the Personal Data Protection Board.<sup>3</sup>

#### **8. Exercising Rights, Application, and Communication**

You can submit your requests regarding the rights mentioned above under the law, by filling out the Data Controller Application Form completely and accurately, signing it with a wet signature, and delivering it in person to the address at **Kurtuluşob Mahallesi Zeki Müren Cadde No:4 Gürsu/Bursa**, or by sending it through a notary or other methods specified in the Law.

#### **9. Links to Other Websites**

The Website contains links to other websites. We have no influence on whether the administrators of these sites comply with data protection regulations. **MYD Endüstriyel** is not responsible for the content of the sites it links to (or the content of other sites that these sites link to) and has no authority to intervene in the content of the sites it links to.

#### **10. Changes**

<sup>3</sup> According to the "Communiqué on the Procedures and Principles of Application to the Data Controller" dated 10.03.2018 and numbered 30356, if the response to the data subject's application is provided in writing, no fee is charged for up to ten pages. A processing fee of 1 Turkish Lira may be charged for each page exceeding ten pages. If the response to the application is provided on a recording medium such as a CD or flash drive, the fee that MYD Endüstriyel may request cannot exceed the cost of the recording medium.
